#### **Business Manager Report – Erik**

- Finance
- Review of Reports as of November 30, 2024
  - We have challenges but are in great shape. Almost 2 million in assets.
- Cemetery
  - City of St. Charles Boone's Lick Flood Remediation Project. Current offer: \$311,483.50. Includes: right of intrusion for future section 4; approved by the Immanuel Board of Properties; Waiting on City of St. Charles final agreement language approval
- Facilities
  - 5/26/24 Hailstorm insurance claim remains open
  - Parking lot improvements completed for 630 First Capitol. Gravel and bumpers were added. All materials were donated. We paid for hauling.
  - Improvements to Handicap entrance is expected in January 2025 pending availability of materials
  - Architectural review underway for Summer 2025 projects: Architect was out last week for measurements. Planning and orders were made for the 3<sup>rd</sup> floor.
  - Sound system in the Fellowship Hall: Getting color samples for the acoustic panels. We will install ourselves

Committee recommends engaging Mission Architects for Second Phase Design:
Early Childhood Center; designed sufficiently for budgetary pricing
